## A. MINUTES:

Motion by Pujol, second by Odegard-Koester, to approve the distributed minutes from the May 4, 2021 University Academic Council Meeting. Motion was approved. 10 in favor, 1 abstention.

## B. ACTION ITEMS:

**New Programs** 

- 1. Harrison College of Business and Computing
  - a. Management
    - i. New Undergraduate Certificate: Family Enterprise Management

Motion by Dávila, second by Schmidt, to consider and approve the addition of a new Undergraduate Certificate in Family Enterprise Management. Kevin Dickson described the new Certificate. Opportunity to do more in the family business area. Certificate is designed for BSBA majors. Uses existing coursework to meet this need. A question was asked about significance of requisites. A question was asked about variation in the Topics course. The Topics course will start out as is and may evolve over time. How many credits would be the prerequisites required to be able to do the certificate? 6-12 additional credits as prerequisite depending on the student's starting point and Gen Ed credits. Godard recommends exploring Industry Recognized Credential to be incorporated if possible. Motion approved unanimously. 12 in favor, 0 opposed.

- 2. College of Education, Health, and Human Studies
  - a. Kinesiology, Nutrition, and Recreation
    - . New Degree: BS in Respiratory Therapy

Motion by Pujol, second by Weller-Stilson, to consider and approve the addition of a new BS in Respiratory Therapy. Pujol described the history of the development of the new degree. Worked with faculty of CTC. Schneider described the elements of the degree and the relationship with the CTC for the coursework. Question regarding the financial aspect of the salaries for faculty in the forms. Salaries are for description of existing resources. This framework is the opposite of the the usual upper level on main campus, discussed any issue with the accrediting bodies. Similar to Radiation Tech and Medical Tech programs. Perhaps hire CTC faculty as adjuncts. Provide an option

for pre-med, pre-vet, pre-dental, nursing candidates to transition in their junior year to the RT degree. A question about capacity for courses offered on our campus. There is availability in the current faculty load. May need to take on their accreditation, may transfer to us as the host institution. Question whether RT prefix is available. Motion approved unanimously. 13 in favor, 0 opposed, 0 abstentions
